Cefndir

Mae safonau'r Gymraeg yn ei gwneud yn ofynnol i awdurdodau lleol fabwysiadu a gweithredu strategaeth 5 mlynedd sy'n esbonio sut maen nhw'n bwriadu mynd ati i hybu'r Gymraeg ac i hwyluso defnyddio'r Gymraeg yn ehangach yn eu hardaloedd.

Mae'r safonau hefyd yn ei gwneud yn ofynnol i awdurdodau lleol asesu i ba raddau maen nhw wedi dilyn y strategaeth honno drwy adrodd ar nifer y siaradwyr Cymraeg yn yr ardal a'u hoedran, a'r gweithgareddau a drefnwyd neu a ariannwyd ganddynt i hybu defnyddio'r Gymraeg yn ystod cyfnod y strategaeth.

Beth oedd yr heriau?

Roedd y wybodaeth a'r gwaith a oedd yn cyfrannu tuag at nod ac amcanion y Strategaeth Hybu yn cael eu casglu'n flynyddol i lunio Adroddiad Blynyddol Safonau'r Gymraeg. Roedd hyn yn golygu cysylltu gydag adrannau'r Cyngor a rhanddeiliaid i gasglu gwybodaeth a data am weithgareddau yn ystod y cyfnod adrodd.

Y brif her oedd yr oedi wrth gasglu'r wybodaeth, y diffyg ymateb i geisiadau ac enghreifftiau o golli gwybodaeth yn sgil diffyg casglu ac arbed data yn effeithiol.

Roedd y broses o gasglu gwybodaeth a data ar gyfer yr adroddiad blynyddol yn broses hir a chymhleth. Roedd angen clir am ddull adrodd mwy cyson i sicrhau nad oedd unrhyw wybodaeth yn cael ei cholli.

Sut aethpwyd ati i ddatrys y broblem?

Mae'r Cyngor yn defnyddio cynlluniau busnes mewnol ar gyfer olrhain cynnydd yn erbyn y Cynllun Corfforaethol a pholisïau allweddol megis Strategaeth Hybu'r Iaith Gymraeg. Er mwyn sicrhau cysondeb, mae gan swyddogion penodol gamau gweithredu'r iaith Gymraeg, gyda chynnydd yn cael ei fonitro a'i adrodd yn chwarterol drwy'r cynlluniau busnes.

Mae adrannau perthnasol yn cynnwys camau yn eu cynlluniau busnes i fonitro safonau'r Gymraeg yn effeithiol. Mae hyn yn cynnwys gosod nodau clir, pennu cyfrifoldebau, a sefydlu amserlen ar gyfer gweithredu. Gweler enghreifftiau o'r cynllun busnes yn yr atodiad.

Mae cynnwys gweithgareddau monitro mewn cynlluniau busnes yn gwella ymwybyddiaeth staff o sut mae eu gwaith yn cefnogi amcanion y strategaeth ac yn sicrhau atebolrwydd. Mae'r Cyngor yn gallu monitro sut mae'r camau hyn yn cael eu rhoi ar waith o fewn adrannau perthnasol. Trefnwyd sesiynau cefnogi i sicrhau bod staff yn deall y camau yn y Cynlluniau Busnes yn llawn.

Mae swyddogion yn derbyn nodyn atgoffa am unrhyw ddyddiadau cau sy'n agosáu a'r angen iddynt ddiweddarau eu hadrannau perthnasol gan ddefnyddio'r dangosyddion perfformiad. Mae'r tîm perfformiad yn cefnogi'r swyddogion trwy gyfarfodydd wyneb yn wyneb chwarterol, a chynhelir awdit bob chwarter i sicrhau bod diweddariadau yn cael eu cwblhau.

Mae cardiau sgorio yn cael eu datblygu i ddangos gwybodaeth allweddol (gan gynnwys cynnydd ar yr iaith Gymraeg) fesul Cyfarwyddiaeth i'r Uwch Dîm Arwain,. Bydd hyn yn galluogi'r Cyngor i adnabod bylchau a rhoi gwelliannau ar waith. Bydd y cardiau sgorio yn cael eu dosbarthu bob chwarter.

Pa newidiadau a wnaed?

Adolygwyd a diwygiwyd polisiau a strategaethau presennol i gyd-fynd â safonau'r Gymraeg ac amcanion y strategaeth hybu. Roedd hyn yn cynnwys ymgysylltu ag amrywiaeth o randdeiliaid a gwneud addasiadau angenrheidiol i sicrhau cydymffurfiaeth.

Datblygwyd Polisi Cymraeg yn y Gweithle ym mis Medi 2023 sy'n cynnwys y camau gweithredu ar gyfer Nod 3 y strategaeth i gynyddu'r cyfleoedd i staff ddefnyddio'r Gymraeg yn y gweithle.

I berswadio rheolwyr, cynhaliwyd ymgynghoriadau a chyflwyniadau mewnol, a chafwyd caniatâd gan uwch reolwyr. Cynhaliwyd ymgynghoriadau mewnol a chyfarfodydd i gasglu adborth a ymgorfforwyd mewn cynlluniau gweithredu.

Roedd trefniadau ymarferol yn cynnwys trefnu cyfarfodydd rheolaidd, gosod systemau monitro, a sicrhau cyfathrebu parhaus rhwng adrannau i wirio cynnydd a mynd i'r afael â materion yn gyflym.

Beth yw'r manteision?

Mae cynnwys pwyntiau gweithredu ym mhrosesau cynllunio busnes y Cyngor wedi bod yn gadarnhaol iawn. Mae wedi gwella monitro a chydymffurfiaeth â safonau'r Gymraeg, gan sicrhau bod y Cyngor yn bodloni ei rwymedigaethau statudol ac yn hyrwyddo'r Gymraeg ar draws pob adran.

Mae hyn hefyd wedi arwain at well cyfranogiad gan a chyfathrebu gyda thrigolion Cymraeg eu hiaith, gwell cynhwysiant diwylliannol, a dull mwy strwythuredig o fonitro cydymffurfiaeth.

Mae cynnwys pwyntiau gweithredu ar gyfer y Gymraeg yng nghynlluniau busnes y Cyngor wedi symleiddio prosesau, lleihau dyblygu, a sicrhau defnydd effeithiol o adnoddau, gan arwain at arbedion cost a gwell defnydd o amser staff.

Mae'r ymateb gan staff, cleientiaid a rhanddeiliaid wedi bod yn gadarnhaol iawn. Mae'r staff yn gwerthfawrogi'r gefnogaeth a chanllawiau clir, tra bod cleientiaid a rhanddeiliaid yn croesawu ymrwymiad y Cyngor i hyrwyddo'r Gymraeg, gan arwain at well boddhad.

Pa gyngor fydddech chi'n ei gynnig i sefydliad sydd yn awyddus i roi trefniadau tebyg mewn lle?

Gall sefydliadau eraill fabwysiadu ffactorau allweddol, megis gosod nodau clir, cynnwys yr holl rhanddeiliaid perthnasol yn y broses gynllunio, a darparu hyfforddiant ac adnoddau digonol. Mae monitro a gwerthuso parhaus yn hanfodol ar gyfer nodi problemau a newidiadau angenrheidiol yn gynnar.

Mae cynnwys pwyntiau gweithredu mewn cynlluniau busnes wedi gwella monitro trwy ddarparu dull strwythuredig o gydymffurfio. Er enghraifft, bu'r Gweithdy Polisi a Pherfformiad a gynhaliwyd ym mis Chwefror 2024 yn trafod safonau'r Gymraeg a sut y cânt eu monitro ar draws pob adran.

Mae rhanddeiliaid hefyd yn tynnu sylw at ymdrechion parhaus i ddatblygu a chynnwys camau gweithredu ymgynghorol lefel uchel mewn cynlluniau busnes.
